Re: Application #O-38351 (South Fraser Perimeter Road)

The Provincial Agricultural Land Commission (the "Commission") has received an application from the Ministry of Transportation and Infrastructure proposing to construct a major transportation facility through the agricultural land reserve ("ALR"). The proposed South Fraser Perimeter Road (SFPR) project will directly affect farmland.

The Commission wishes to have a meeting with persons currently owning or farming ALR land which is proposed to form part of proposed SFPR route through Delta. The Commission has booked the Terrace Room at the Delta Town & Country Inn (6005 Highway 17) on Thursday September 11, 2008 for a meeting starting at 5:00 p.m. and ending not later than 6:30 p.m. Farmland owners who rent their lands to farmers are welcome to attend but are also encouraged to inform their tenants of the meeting.

The Commission will also be holding a meeting in the same room starting at 7:00 p.m. that evening to hear the views of the broader Delta farm community regarding the South Fraser Perimeter Road proposal and its effects on farming in Delta. If space permits, you are welcome to attend that meeting as well.

Later in the month, the Commission will be holding an official meeting with the Ministry of Transportation and Infrastructure to review the application. It is expected that the Ministry will at that time make a presentation to the Commission including information obtained at meetings it will be holding in Delta this month. The Ministry is entitled to observer status at the September 11 meetings, but is not expected to make a presentation at that time.
