#### RESOLUTION TO RESOLVE INTO COMMITTEE OF THE WHOLE

OCP Rez 7445 – 120 St (Parmar) (A.01) Report by the Community Planning and Development Department dated October 2, 2007 regarding Official Community Plan Amendment, Rezoning, Development Permit and Development Variance Permit – 7445 – 120 Street (Parmar). (File: LU05149 & B/L's 6413 & 6414)

At the November 5, 2007 Regular Meeting, the following motion by Councillor Kanakos, seconded by Councillor Hawksworth, was postponed in order that the applicant be invited, to provide additional information and address the issues raised at the November 5, 2007 meeting.

- A. THAT first and second readings be given to Bylaw No. 6413, 2007. (This bylaw would amend "The Corporation of Delta Official Community Plan Bylaw No. 3950, 1985" for the property at 7445 120 Street as follows:
  - 1. by changing the land use designation in the Future Land Use Plan in Schedule A from Multi-Unit Residential (MR) to Town Centre (TC);
  - 2. by changing the land use designation in the North Delta Future Land Use Plan in Schedule C.1 from Medium Density Ground Oriented Residential (MGR) to Mixed-Use (North Delta) 4 (MU(ND)4); and
  - 3. by designating the subject property as part of the Scott Road Corridor (SRC) Development Permit Area, and amending Map IIc North Delta in Schedule E accordingly.)
- B. THAT the Official Community Plan, as amended, be confirmed as being consistent with the Current Financial Plan, and the Liquid and Solid Waste Management Plans, as required by the Local Government Act.
- C. THAT the consultation process for Bylaw No. 6413 described in this report be approved in accordance with Section 879 of the Local Government Act.
- D. THAT first and second readings be given to Bylaw No. 6414, 2007. (This bylaw would amend "Delta Zoning Bylaw No. 2750, 1977" to rezone the property at 7445 120 Street from RM1 Multiple Family (Duplex) Residential Zone to CD 344 zone to permit the development of a four-storey mixed-use building with 51 residential units and one storey (ground floor) of commercial.)
- E. THAT Development Permit No. LU05149 be considered. (This Development Permit would regulate the form and character of the proposed mixed use development, generally in accordance

with the attached drawings.)

- F. THAT Development Variance Permit No. LU05149 be considered. (This Development Variance Permit would vary Part X of "Delta Zoning Bylaw No. 2750, 1977" to waive the Special Setback from the centre line of 120 Street in order to permit the proposed mixed-use building; and vary Section 5.2 of Delta's "Subdivision and Development Standards Bylaw No. 5100, 1994" to allow acceptance of cash-in-lieu of underground electrical and telecommunication wiring on 120 Street.)
- G. THAT Bylaws 6413 and 6414, Development Permit No. LU05149, and Development Variance Permit No. LU05149 be referred to a Public Hearing.
- H. THAT the owners satisfy the following requirements as a condition of final bylaw adoption and permit issuance:
  - 1. Enter into a Section 219 Restrictive Covenant for building design and landscaping, to the satisfaction of the Director of Community Planning & Development;
  - 2. Enter into a Section 219 Restrictive Covenant to ensure that, before a Strata Subdivision Plan can be registered, the owners will provide cash in lieu of open space in the amount of five percent of the value of the land,
  - 3. Provide water meters;
  - 4 Develop a tree replacement strategy to the satisfaction of the Director of the Community Planning & Development Department; and
  - 5. Provide \$4,500 to cover the cost for the purchase, installation and establishment of nine street trees (\$500/tree).
- I. THAT all measures to protect trees on the subject site and on adjacent public property be reviewed and inspected by Delta staff and deemed acceptable prior to the issuance of a building permit/demolition permit.
- J. THAT the Mayor and Municipal Clerk be authorized to sign all documents pertaining to this development.

Accordingly the applicant will be in attendance to provide information and respond to questions of Council.
